Such cancellation or termination shall not affect any liability incurred or accrued thereunder prior to termination or cancellation of said bond by said City of Canton, Ohio, or prior to termination or cancellation of said bond by said City of Canton, Ohio, or prior to the termination of the thirty (30) day period for notice, if terminated by the surety.
